

This Directorate reserves the right to make the purchase from any other source available without sending any information of cancellation of the order placed with you at the earliest to DOGR, Rajgurunagar.
2. Net Payable amount is inclusive of all taxes. No other payment shall be paid.
3. Delivery & installation at this office premises & no extra charges shall be paid for these.
4. Warranty 12 Month from the date of installation.
5. 10% security deposit/performance guarantee of total ordered value i.e. Rs.18470/- is required to submit in form of D.D. in favour of "ICAR Unit-DOGR" payable at SBI Rajgurunagar which is refundable as per existing norms. The security deposit should be submitted before supplying the equipment. If supply is not completed within stipulated period 10% Security Deposit/Performance guarantee will be forfeited as per Rules.
6. After 1 year warranty period Comprehensive AMC including service/repair Replacement of part charges, Labours and transportation charges as under for 5 years
AMC 1st to 3rd years @ Rs. 30,000.00 per year
