The shortlisted candidates are required to be ready **one hour before the scheduled reporting time (i.e. by 9.00 a.m.) on 02 September 2026**. At the scheduled time, this Directorate will provide the **online meeting link (Zoom ID and Passcode)** to the concerned candidates. Upon receiving the link, candidates are required to **immediately log in and remain in the waiting room** until they are called for the interview.

Candidates who wish to appear for online Video Conference Interview (candidates from the mentioned list) are required to log in immediately using the link provided and remain in the **waiting room** until they are called for the interview. **Candidates who wish to appear Walk-In-Interview/ In-Person/ Offline Interview (candidates from the mentioned list) are required to report on 02.09.2026 at 9.00 a.m.**

Therefore, all candidates are advised to ensure the availability of a stable internet connection and a suitable device, such as a mobile phone or computer. They should also ensure that the camera, microphone, and other necessary equipment are in proper working condition before the scheduled interview.

2. Walk-In-Interview/ In -Person Interview/ Offline Interview only (In addition to the above mentioned list)

Candidates who wish to appear for the **In-Person Interview** are required to report at this Directorate **only on 02 September, 2026, i.e. 60 minutes before the scheduled time (i.e. by 9.00 a.m.)**.

Such candidates shall bring the following documents:

- One duly filled-in set of the application form, with a **passport-size photograph affixed at the prescribed place**;
- Duly signed **declaration** in the application form;
- Duly **self-attested copies** of all supporting documents/certificates, including:
 - Proof of age;
 - Category certificate, wherever applicable;
 - Educational qualification certificates and mark sheets from **10th Standard onwards**;
 - Experience certificates;
 - Research publications, wherever applicable; and
 - Other documents as specified in the prescribed checklist.
- **Original certificates/documents** for verification.

The candidates opting for the In-Person Interview will also be **shortlisted as per the prescribed/fixed criteria applicable to the Online Video Conference Interview**. Only the candidates shortlisted after such scrutiny will be permitted to appear for the interview.

In case the interview process is not completed during the office hours on **02 September, 2026**, the remaining interviews will be conducted on **03 September, 2026**.
